Exhibitor Terms and Conditions of Sale

- Space will be allocated on a preference based order when initial deposits have been received. You are required to complete the information requested and return it with a deposit of 50% to secure your exhibition attendance for AusMedtech 2010. All space is held tentatively until final payment is received.
- Confirmation of space and booths number will be finalised on final payment being made 26 March 2010, If final payment is not received by 30 April 2010 , the space and booth will be released and any deposits will be forfeited.
- For exhibitor application forms that are received after 30 April 2010, full payment must be received before confirmation is confirmed.
- Credit cards will be accepted for exhibition payments. A 3% surcharge will be charged to the credit card at the same time as process payments. The 3% charge will appear as a separate charge on your credit card statement.
- AusBiotech must receive all payments either by credit card, direct deposit or Australian cheques. The payment form is part of this document and must be completed before processing.
- Any exhibitor that is co-sharing their booth space must notify AusBiotech of the co-sharer's details no later than 28 May 2010. If this information is not received the companies will not be included in the pocket program book.
- Entitlements must be taken up and confirmed in writing no later than 1 August 2009. If notification of additional attendees attendance as per the exhibition entitlements has not been received by AusBiotech by this date all entitlements may be forfeited.
- In the event of cancellation a service fee of \$500 will be applied to cancellations received prior to 30 April 2010. No refunds will be made for cancellations received after this date.
- Any space not claimed and occupied before 12 noon on Tuesday 1 June 2010 may be reassigned.
- AusBiotech Ltd reserves the right to rearrange the floor plan and relocate any exhibit without notice. No refunds or discounts will be given for any facilities not used or required.
- Custom stand requirements must be forwarded to Moreton Hire for approval. All display and construction requires the approval of Moreton Hire.
- AusBiotech complies with the principles of permission-based marketing and will use your information to send you updates and other news about related services or events. Your information will only be passed on to reputable third party official contractors of the Conference for the purpose of assisting you with your program.
